### **WALK-IN ADVOCACY CLINIC (WAC)**

CLASSIC administers a Walk-In Advocacy Clinic that provides clients with legal information and/or basic legal services. CLASSIC clients are assisted by law student advocates under the supervision of a practicing lawyer. CLASSIC provides advocacy services in areas that include: landlord-tenant issues, social assistance, CPP, Indian Residential School matters, EI, labour standards, SGI matters, immigration and refugee, human rights, workers' compensation, and more.

### **LEGAL ADVICE CLINIC (LAC)**

CLASSIC administers the Legal Advice Clinic, a complementary service to the Walk-In Advocacy Clinic. The Legal Advice Clinic allows clients who have legal issues in the areas of criminal law, family law, or civil law to speak to a practicing lawyer for a one-time, half-hour appointment. In contrast to the Walk-In Advocacy that provides services on a walk-in basis, the LAC is only accessible by appointment.

*\*Both clinics have an income criteria that must be met*
